

- 4. The application should be self-attested.
- 5. The new Study Centre/franchise fee Rs.3600/- (Three thousand Six Hundred) should be make net/online payment to "TALLYSAP INFOTECH FOUN DATION" franchise fee is Non-refundable.
- 6. Attached photocopy of ID proof of chairman/secretary/principal and address proof.

RULES FOR ACCEPTANCE OF NEW STUDY CENTER
